## Section 4. First aid measures

### Description of necessary first aid measures

## Section 6. Accidental release measures

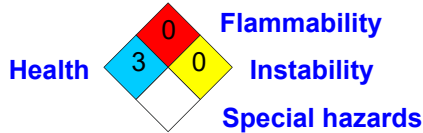
